

## **DIGITAL MILLENNIUM COPYRIGHT ACT (DMCA) NOTICE**

1. An address, telephone number, and e-mail address where Maui Lifestyle Properties, LLC can contact you and, if different, an e-mail address where the alleged infringing party, if not Maui Lifestyle Properties, LLC can contact you.
2. A description of the copyrighted work or other intellectual property that you claim has been infringed.
3. A description of where the material that you claim is infringing is located on the site.
4. A statement that you have a good-faith belief that the use is not authorized by the copy right owner or other intellectual property rights owner, by its agent, or by law.
5. A statement by you under penalty of perjury that the information in your notice is accurate and that you are the copyright or intellectual property owner or are authorized to act on the owner's behalf.
6. Your electronic or physical signature.

Maui Lifestyle Properties, LLC may request additional information before removing any allegedly infringing material. In the event Maui Lifestyle Properties, LLC removes the allegedly infringing materials, Maui Lifestyle Properties, LLC will immediately notify the person responsible for posting such materials that Maui Lifestyle Properties, LLC removed or disabled access to the materials. Maui Lifestyle Properties may also provide the responsible person with your e-mail address so that the person may respond to your allegations.
